3-Day Notice to Quit (Non-Payment of Rent) This form of notice is used when a tenant has failed to pay rent when it is due under the terms of the lease. The landlord may send this notice and the tenant has three days to respond by either paying the rent or moving out of the premises.

The eviction notice required in Florida for non-payment of rent is this 3 Day Notice. If your tenant fails to pay the rent, serve this eviction notice on them immediately. After three days, if the renter has still failed to either pay the owed rent or vacate, the landlord may file in court for an eviction motion. The court then sets a date for a hearing several weeks (or even months) later.
